II. Approval of Minutes

1. FY2010 Budget Review

A motion was made by Mark Brophy and seconded by Ned Kelly to adopt the FY2010 budget in the amount of \$32,652,425 as detailed in FY10 Appropriation Control Report dated September 17, 2009.

A discussion ensued.

The Chair asked that the vote be taken in subsections:

- a) Section 2100-3200 Instructional Support in the amount of \$15,399,381 was approved by a vote of 9-0-2. Mr. Barringer and Ms. Bolger abstained.
- b) Section 3510-3520 Athletics & Student Activities in the amount of \$487,576 was approved by a vote of 10-0-1. Ms. Thompson abstained.
- c) Section 2100-3200 Special Education Instructional Support in the amount of \$3,011,850 was approved by a vote of 10-0-1. Mr. Barringer abstained.
- d) A roll call vote was taken on the main motion to adopt the FY10 budget in the amount of \$32,652,425. The vote went as follows (2/3 majority is required):
