5. UNFINISHED BUSINESS

• FY16 Budget vote – Superintendent Marshall and Director Duval presented on the FY16 budget and a lengthy discussion ensued in regard to the preliminary budget, House Budget, and the cuts that have been made (see attached PowerPoint presentation). Budget figures and assessment figures for the district towns were discussed. Our preliminary budget showed an increase of 8.53% which represented an average increase of 27.16% in assessments to the towns. The District is aware that, as the figures stand now, these assessments will be very difficult for the district towns. Discussion ensued as to where cuts can be made without affecting the quality of education for our students. Cuts discussed included requested positions, technology cuts, with additional discussion of cutting the football program, middle school athletics, and an elementary school.

Motion made by Mr. Wigler and seconded by Mr. Labarre to adopt an FY16 budget in the amount of \$32,984,111 which includes \$16,330,943 in Chapter 70 Aid and \$331,623 in district revenues and reserves to offset member town assessments.

Due to conflicts of interests of some members of the School Committee, the Committee will vote on the following appropriation categories independently of the total budget appropriation:

Line 3510-3520 Athletics & Student Activities in the amount of \$539,782. Line 1450-2250 Technology in the amount of \$629,315.
