2. A motion was made by Ned Kelly and seconded by Charles Miller that the Quabbin Regional School District Committee endorse the following changes to the motion voted upon at the January 20, 2011 meeting in regard to the performance specifications for the atrium roof skylight:

Item 11 will change to "The system includes an R-7 system;

Item 12 will change to "Light transmittance design 30 foot candles (FC) become 20.2-40 FC at the cafeteria table.

3. FY12 Preliminary Budget
  - a. A motion was made by Mark Brophy and seconded Tex Sarabia to approve Appropriation Category 2100-3200 Instructional Support for FY12 in the amount of \$13,078,127.

- b. A motion was made by Mark Brophy and seconded by Tex Sarabia to approve Appropriation Category 3510-3520 Athletics & Student Activities for FY12 in the amount of \$511,038.

- c. A motion was made by Mark Brophy and seconded by Tex Sarabia to approve Appropriation Category 2100-3200 Special Education Instructional Support for FY 12 in the amount of \$3,434,873.

The motion passed by a vote of 9-0-2.

- d. A motion was made by Mark Brophy and seconded by Tex Sarabia to approve the FY12 Preliminary Budget in the amount of \$31,602,916 which includes \$16,073,093 in Chapter 70 Aid; \$620,983 in Chapter 71 Aid; \$11,250 in Charter School Reimbursement Aid; and \$670,545 in district revenues and reserves to offset member town assessments ; including \$351,542 from Excess & Deficiency (E & D).

The motion passed unanimously.
